

#### Check- list for the eligibility of the application

The Belgian Federal Science Policy will verify that each application meets all the eligibility criteria described in [the information note](#). Applicants of ineligible proposals will be informed. The eligibility of an application is checked by means of the information supplied in the [official application form](#). This check-list is intended to help to fill out the application form. Please note that a [FAQ](#) is also available.

#### List of criteria

For any introduced application, the following criteria will be checked. Only those meeting ALL criteria will be assessed by a jury of independent experts.
