3. CONSEQUENCES OF THE APPROVAL

3.1 Hosting Agreements

An approved Research Organisation wishing to host a Researcher for the purpose of a Research Project signs a hosting agreement with the researcher in question. By virtue of this agreement, the Researcher undertakes to complete the Research Project, and the Research Organisation undertakes to host the researcher for this purpose.

On the basis of this hosting agreement, the Researcher may apply to the Belgian diplomatic or consular post in his or her country of residence or place of stay abroad for a residence permit lasting longer than three months, on condition that he/she produces the documents required by the Law of 15th December 1980 on entry to the country, stay, settlement and expulsion of aliens, as modified, and that the situation of the interested party does not fall within any of the cases listed in Article 3, Paragraphs 1 and 5 to 8 of this Law.

3.2 Responsibilities of the Research Organisation

A Research Organisation entering into a hosting agreement with a Researcher undertakes to host the Researcher for this purpose, and ensures that the conditions laid down in Article 9 of the Royal Decree for approval of research organisations wishing, in the context of research projects, to enter into hosting agreements with researchers from non-European Union countries and laying down the conditions in which such hosting agreements can be entered into, have been met.

On the other hand, if the Researcher remains illegally on Belgian territory, the Research Organisation must reimburse the expenses incurred by his or her stay or return and borne by public funds (Article 4 of the Royal Decree containing the conditions for approval of research organisations wishing, in the context of research projects, to enter into hosting agreements with researchers from non-European Union countries and laying down conditions in which such hosting agreements can be entered into).

N.B. responsibility for hosting starts on the date of signature of the hosting agreement and terminates six months after the end of this agreement, or as soon as notice is received that access to the country being refused.

3.3 Duration

In the event of acceptance by the Federal Scientific Policy Office, the approval is issued for a period of 5 years (Article 5 of the Royal Decree containing the conditions for approval of research organisations wishing, in the context of research projects, to enter into hosting agreements with researchers from non-European Union countries and laying down conditions in which such hosting agreements can be entered into).

3.4 Publication

The list of research organisations approved by the Federal Scientific Policy Office is published on the website www.belspo.be and may be published on the European Union website.
